- 4. Entry Instructions:** To enter the promotion, you will be automatically entered once you attend and check in via the QR code at a parkrun event each week during the six-week campaign. We cannot be responsible for missed check ins via the QR code, that is the participants sole responsibility throughout the six weeks.
